SEVENTH AMENDMENT TO DECLARATION OF SUBMISSION OF PROPERTY TO HORIZONTAL PROPERTY REGIME PURSUANT TO CHAPTER 499B OF THE CODE OF IOWA FOR

GATEWAY COMMERICAL CONDOMINIUMS

- 1. The condominium regime known as Gateway Commercial Condominiums is located on the following described real estate situated in Johnson County, Iowa, to wit:
 - Lot 2 of Gateway First Addition, Johnson County, Iowa as recorded in Plat Book 37, Page 326, Plat Records of Johnson County, Iowa.
- 2. The Declaration of Gateway Commercial Condominiums as previously amended is hereby further amended by adding the following new paragraph 4 to Article IX thereof:
 - Fireworks Restriction. Notwithstanding anything contained herein to the contrary, no Building, Unit, parking area or common area shall be used for the sale or storage of fireworks. Furthermore, all Unit Owners, guests and invitees thereof, shall be prohibited from discharging any fireworks from any property located within the Gateway Commercial Condominiums Regime. The term "fireworks" as used herein shall include, but not be limited to, all first class and second class consumer fireworks defined in section 100.19 of the Iowa Code.
- 3. The above-referenced Amendment to the Declaration were adopted, pursuant to Article XII of the Declaration, as previously amended, by an affirmative vote of at least 50% of all owners entitled to vote.
